Currently the 2014 Ford Escape does not have towing capability or 4WD. Discussion followed and Chairman Anthony advised Director Hickey to seek out vehicle and quotes that will be looked at in 2022.
- Roger Peterson and Deidre Petrosky both recommended to Director Hickey that he speak to the
  auditor's office to inquire if a line item identified as Misc./Contingency in order to have funds
  immediately available in an emergency. Director Hickey advised he will look into it and report
  back at the January 2022 Executive Board meeting.
- Jeff Tucker thanked Director Hickey for the information that was provided to the board, specifically the proposed 2022 budget information.
