Director Hickey has indicated that things are not going well with the morgue being in the garage for the EMA, or the Coroner's office. It was agreed by the board that they will attend a TC Commissioners workshop to discuss the situation.
- Director Hickey provided an update of the Special Operations Group. Chairman Anthony requested a list of the teams and personnel be sent to the board. Director Hickey advised he will complete this prior to the next board meeting.
- Director Hickey advised that the Tribune did not print the meeting in the agenda section as requested. Email was shown to the board to show proof that it was requested.

- Discussion was held about setting a limit of what the director could approve for inter-fund transfers within the 023 EMA account. Chairman Anthony recommended it be set at \$2,000.00, and anything else above that would need the approval of the board.
