OLD BUSINESS (Continued)

- Director Hickey advised that the TCEMA Executive Board meeting announcements will be placed on the TCEMA website, in addition to the regular advertisement in the Warren Tribune. This was in accordance with the board recommendation at the March 2025 meeting.
- Discussion about the old Bazetta Fire Station walkthrough was conducted. Director
 Hickey reiterated that he wants the TCSO to remain a partner at the facility and is not
 trying to move them out. Sheriff Wilson expressed concern about the size of the
 proposed garage, stating that the 30'by 40' garage that the director proposed would not
 be big enough to house the dive and water rescue equipment. Director Hickey advised
 he would work with Sgt. Wix and Sgt. Carr to determine what square footage they will
 need. Director Hickey advised that ultimately the final decision and funding for the
 project will come from the Trumbull County Commissioners.

NEW BUSINESS

- Director Hickey spoke about the proposal to use excess funding from the mobile command post to accomplish the updates needed at the old Bazetta Fire Department. After discussions with the county prosecutor's office and the TC County ARPA attorney, it was determined that the excess funding could not be used for this project due to the fact the money was not encumbered for this project prior to the 12/31/2024 deadline.
- Ohio EMA NE Regional Operations Chief Bob Zethenbauer introduced himself to the board and advised the board to reach out to his office if he can be of any assistance with EMA issues, or the SERC/LEPC Exercise program.
