## • OHIO EPA/Spill Report:

#### • OLD BUSINESS:

Bylaw rewrite project still ongoing. Director Hickey working with Shara Taylor on this project.

Director Hickey advised that the Functional Exercise for our annual LEPC exercise will be conducted on Wednesday May 29, 2024 starting at 0900, at the Mahoning Valley Sanitary District (MVSD). Invites will go out to all LEPC members to attend the exercise as observers.

#### NEW BUSINESS:

Accept 2024 Go Green Grant in the amount of \$3,223.49 through the Geauga Trumbull Solid Waste District. This grant will allow the TCHMRT to purchase (1) MSA 4 Gas detector, (2) universal probes, and calibration gas. This is a reimbursement grant, and funds were paid out of the 072 account, and once the reimbursed grant monies are received, they will be deposited back into the 072 account.

#### **MOTION:**

Grant Taylor made the motion to accept the 2024 Go Green Grant from the Geauga Trumbull Solid Waste District in the amount of \$ 3,223.49 that will be used to purchase operational equipment for the TCHMRT.

Director Hickey advised that he submitted the 2024 Ohio EPA Right to Know grant application through the Ohio State Emergency Response Commission (SERC) in the amount of \$7,600.00. This grant is the primary funding source for the Trumbull County LEPC), and in addition HM training, and a pallet of F-500 firefighting Encapsulator Agent was requested in order to be dispersed to county fire departments when fighting electric vehicle fires, and other lithium battery emergencies.

Director Hickey advised that he submitted the 2024 Hazardous Materials Emergency Preparedness(HMEP) grant in the amount of \$18,000.00. This grant will pay for the 40 Hour Hazardous Materials Technician class, and a 40 hour Hazardous Materials Officer/Safety Officer class.
