Diane said that she had team work with the Senior Levy Advisory Council members working together for the betterment. She thanked Commissioner Frenchko who was the chair on the board for her hard work and dedication.

Mr. Fuda asked Gary Shaffer about some road closing signs that were moved off to the side of the road at Tibbetts Wick and Logan Avenue.

Gary Shaffer addressed Mr. Fuda's questions.

Commissioner Cantalamessa acknowledged Al DeVengencie's retirement after 48 years of service to Trumbull County. He congratulated Al and said he will be missed and wished him the best.

Commissioner Frenchko asked if someone reached out to Al DeVengencie regarding the information that she requested from him regarding procedures manuals. She asked if Mr. Steve Charles could ask Mr. DeVengencie for this information.

Commissioner Cantalamessa said that Mr. DeVengencie is leaving shortly and it wouldn't be possible to get the information at this late of date.

Sharon March asked if the Commissioners would be appointing Senior Levy board members shortly and if they would be interviewing for the members.

Commissioner Cantalamessa addressed Ms. March's questions.

Myrda spoke about the deadline for the transportation survey and where the survey can be accessed.

Ed Agler commended Al DeVengencie and his staff and said that Al is very much appreciated and would be greatly missed.

Mike Salamone spoke about the number of transportation trips in 2020 given by three providers. He said there were 57,134 rides and this was during the COVID Pandemic.
