FRENCHKO VOTED 'NO' STATING ECONOMIC SHOULD BE DONE BY THE COMMISSIONERS AS THEY HAVE THE REGIONAL CHAMBER, THE PORT AUTHORITY, AN EMPLOYEE AT THE PLANNING COMMISSION, MAHONING VALLEY ECONOMIC PARTNERS—SHE WENT ON TO STATE THEY HAVE SO MANY DIFFERENT SPLINTERED AGENCIES THAT ARE WORKING TO TRY TO BRING ABOUT ECONOMIC DEVELOPMENT IN TRUMBULL COUNTY AND ITS NOT PROGRESSING AT ANY HIGH RATE OF SPEED WITH ANY OUTCOME MEASURE THAT SUGGEST THEY ARE ALL WORKING IN A WAY TO MAKE GOOD THINGS HAPPEN. SHE SAID THEY NEED TO HAVE BETTER CONTROL AS COMMISSIONERS AND REDIRECT FUNDING THAT'S GOING TO OTHER PLACES TO BUILD A BETTER TEAM OF INDIVIDUALS WHERE OTHER COMMUNITIES HAVE ONE OR TWO INDIVIDUALS THAT ACTUALLY GO INTERNATIONALLY TO WORK ON ECONOMIC DEVELOPMENT. SHE SAID THEY HAVE TOO MANY AGENCIES WORKING ON THESE THINGS WITHOUT REAL ACCOUNTABILITY TO THE BOARD AND WHEN THEY DON'T HAVE GROWTH, THEY GET BLAMED, SO SHE PREFERS TO SEE THE BOARD RESPONSIBLE FOR THIS INSTEAD OF THE PLANNING COMMISSION WHICH WOULD HAVE ONE PERSON THAT WOULD BE ACCOUNTABLE TO THE PLANNING COMMISSION BOARD AND NOT THE **BOARD OF COMMISSIONERS.**

Ms. Frenchko spoke about required letters written by agencies requesting ARPA Funds and shared concerns regarding 911 being combined with the Sheriff's request without a letter that could potentially lead to a finding for recovery. She said although she disagrees with the item, she thinks the two requests should be separated with the Sheriff's going first until a request letter is received from 911. Mr. Misocky said the application came from two Commissioners from a public meeting, and an audio tape was sent to ARPA Counsel. There was discussion regarding an email sent from ARPA Counsel, public meetings, discussion for spending 3 mil ARPA Funds, ARPA money, General Fund Money, conversations with County Auditor, public meeting to decide what they want for their budget next year.
