Chief D. Rea motioned to adjust EMA Directors base pay from \$31.25 per hour (\$65,000.00 per year salary) to \$34.06 per hour (\$70,844.80 per year salary) This adjustment was recommended per the Trumbull County Auditor, and will eliminate the 9% pension pick up that the County was paying for the director. This amount is now placed in the salary of the EMA director, and the county will not pay any portion of the employee pickup. The amount that will be paid by the director each pay will now be \$272.50 per pay period.

- Request that James McBride, of Warren Township Fire be accepted onto the team as a Hazardous Materials Technician.

5. TRUMBULL COUNTY FIRE INVESTIGATIVE UNIT
