WITNESSETH THAT:

WHEREAS it is the desire of the parties hereto to develop land conforming to acceptable standards, which will include, but not limited to the construction of roadways, parking and storm water drainage facilities within _____ Township, in accordance with the detailed plans and specifications as prepared by

Subject to all the current rules, regulations and specifications of the **Trumbull County Drainage and Erosion and Sedimentation Control Manual** as administered by the Trumbull County Engineer.

NOW THEREFORE, for good, valuable and adequate consideration from each of the Parties hereto, and of the mutual covenants hereinafter contained, it is agreed by and between the parties hereto.

1. The Developer agrees to furnish a set of construction drawings and specifications satisfactory to the "Engineer", including all necessary surveys, engineering and calculations incidental thereto and that said plans shall be approved by the Trumbull County Engineer. Upon completion the storm water detention facilities, a set of "As-Built" drawings shall be provided to the "Engineer's" office in the form of an electronic copy and/or hard copy assuring that the improvements have been constructed per the approved plans. If an electronic copy is provided, then said copy is to be saved in Auto CAD or in the DFX (Drawing Interchange File) format. The drawings should be saved on a USB Flash Drive.

2. The total cost of the "Engineer's" personnel regarding plan review and the inspection of the roads and storm drainage shall be borne by the Developer. The "Engineer" sets an hourly fee in the amount of \$50.00/hour as currently established.
3. Upon completion of the plan review the Developer shall pay the Engineer's invoice for said review and upon completion of the roads and storm drainage construction and prior to the Engineer's issuance of approval of the construction the Developer shall pay the Engineer's invoice for the inspection services.
4. The provisions of this agreement shall be in full force and effect from and after the signatures of both parties have been affixed hereto.

It should be noted that this agreement is in effect only to cover the review and inspection fees associated with constructing roads and storm drainage. The proceeding and all other applicable requirements are to be in compliance with the Trumbull County Drainage and Erosion and Sedimentation Control Manual.

The Engineer's review is only for conformance with the Trumbull County Engineer's design concepts and compliance with the Trumbull County Engineer's standards as they relate to the County Engineer's office. It is not intended in any way to relieve either the Developer or the Consultant and/or their agents of their responsibility to complete the work in accordance with good engineering principles and practices and the requirements of all local, state and federal governing codes and ordinances. Review by the Trumbull County Engineer constitutes neither expressed nor implied warranties as to the fitness, accuracy or sufficiency of the plans, designs. or specifications.
