UPCOMING PROJECT INFORMATION: TRUMBULL COUNTY ENGINEER PLANS INTERSECTION IMPROVEMENTS AT ELM ROAD/REEVES ROAD/GENESEE AVENUE IN THE CITY OF WARREN AND HOWLAND TOWNSHIP

The Trumbull County Engineer's Office proposes improvements at the intersection of Elm Road, Reeves Road, and Genesee Avenue, located within the City of Warren and Howland Township. This project is part of our ongoing efforts to improve traffic flow, enhance safety, and ensure accessibility for all road users.

The proposed project will reconfigure the existing intersection and includes the following key improvements:

- Extension of the existing right-turn lane from Genesee Avenue to eastbound Elm Road
- · Addition of a dedicated left-turn lane from Genesee Avenue to westbound Elm Road
- Removal of the current connection from Reeves Road to Genesee Avenue
- · Installation of dedicated left and right turn lanes on southbound Genesee Avenue
- Restriping Genesee Avenue to permit two-way traffic on Genesee Avenue as it connects to Reeves Road
- · Replacement of the existing traffic signal
- · Reconstruction of driveway aprons
- Removal, reconstruction, and/or installation of sidewalks and curb ramps in compliance with Americans with Disabilities Act (ADA) standards
- Drainage improvements and new pavement markings, as necessary, throughout the project limits

The \$865,000 project is scheduled to begin construction in the summer of 2026 and will be completed by the summer of 2027. No permanent or temporary right-of-way acquisition is required for this project.

During construction, Genesee Avenue will not have access to Elm Road and vice versa (Elm won't have access to Genesee). Traffic will be detoured along Atlantic Street NE to Elm Road or Genesee Avenue. Construction, road closure/detour information will be posted along Elm Road, Reeves Road, Genesee Avenue and all intersecting side roads and on the Trumbull County Engineer webpage, http://engineer.co.trumbull.oh.us, prior to the start of construction activities. Access to all residential and commercial properties within the construction limits will be maintained at all times during construction of the project.

While the proposed project will not result in any substantial impacts to environmental resources, Trumbull County Engineer, David DeChristofaro, is seeking comments you may have regarding the social, environmental, and economic impacts of this proposed project. Project-related issues you may wish to comment on include, but are not limited to, the effect of the project on the environment, residents, the local economy, historic or cultural resources, etc.
