UPCOMING PROJECT INFORMATION TRUMBULL COUNTY ENGINEER PLANS RESURFACING ON SALT SPRINGS ROAD AND NILES CARVER ROAD IN WEATHERSFIELD TOWNSHIP

Trumbull County Engineer, David DeChristofaro, in cooperation with Weathersfield Township, proposes to improve Salt Springs Road and Niles Carver Road in Weathersfield Township, Trumbull County, Ohio. The project proposes to mill and resurface approximately 0.90 miles of Salt Springs Road from Austintown Warren Road to Salt Springs Road. Additionally, the project proposes to mill and resurface 0.93 miles of Niles Carver Road from Salt Springs Road to the southern Niles corporation limits. Additional work includes the replacement of three (3) culverts on Salt Springs Road between Austintown Warren Road and Carson Salts Springs Road and the replacement of two (2) culverts on Niles Carver Road between McKees Lane and Salt Springs Road. The project also proposes partial-depth pavement repairs, and the application of pavement markings, as necessary, throughout the newly paved sections of Salt Springs Road and Niles Carver Road. This \$750,000 project is scheduled to begin construction in the spring/summer of 2026.

During construction, traffic will be maintained at all times on Salt Springs Road and Niles Carver Road, except when it is necessary to close Salt Springs Road and Niles Carver Road for a maximum of fourteen (14) consecutive days during the replacement of each cross culvert. The official detour route for the closure of Salt Springs Road will utilize Austintown Warren Road and Salt Springs Road. The official detour route for the closure of Niles Carver Road between Ohltown McDonald Road and the southern Niles corporation limits will utilize Ohltown McDonald Road, Salt Springs Road, State Route 46 and McKees Lane. The official detour route for the closure of Niles Carver Road between Ohltown McDonal Road and Salts Springs Road will utilize Ohltown McDonald Road and Salt Springs Road. These closures will not occur simultaneously. All necessary signage will be posted within the project construction limits and all intersecting side roads. Access shall be maintained to all adjacent properties, businesses and intersecting side streets within the construction limits for the duration of the project.

The project will result in minor stream and wetland impacts and the removal of habitat for various species protected by the Endangered Species Act. No cultural resources will be affected by the project and no regulated material concerns were identified.

As part of the environmental process for the project, Trumbull County Engineer, David DeChristofaro, is seeking any comments the public may have regarding the proposed project. Project-related issues the public may wish to comment on include, but are not limited to, the effect of the project on residents, businesses, the local economy, historic or cultural resources, etc.
