Fine for working without permit	This will be assessed to the total cost of a floodplain permit for any development undertaken prior to receiving a floodplain development permit.	
Commercial	This applies to development activity within parcels containing Special Flood Hazard Areas where the land is designated for business activities. This encompasses retail, office, multi-family dwellings of 3 units or more, and other Industrial enterprises.	
Residential	This applies to development activity within parcels containing Special Flood Hazard Areas where the land designated for housing, encompassing various forms like single-family homes, multi-family dwellings not greater than 2 units, and manufactured homes.
