

32 cases indicted by Trumbull grand jury

WARREN – A Trumbull County grand jury on Wednesday, November 1, 2023, returned 32 indictments, including four felony cases that were sealed.

The following felony indictments were made, with arraignments set within two weeks in the courtrooms of one of four Trumbull County Common Pleas judges:
