

# 20 cases indicted by Trumbull grand jury

WARREN – A Trumbull County grand jury on Wednesday, November 29, 2023, returned 20 indictments. Half of the cases are drug-related.

The following felony indictments were made, with arraignments set within two weeks in the courtrooms of one of four Trumbull County Common Pleas judges:

- Terry L. Allen Jr., 33, Harvard Drive, Warren, tampering with evidence;
- Cameron L. Mayfield, 23, Maple Street, Niles, possession of fentanyl-related compound, possession of cocaine and failure to comply with order or signal of police officer;
- Maxwell C. Lottig, 30, North River Road NW, Warren, possession of fentanyl-related compound;
- John Monteneri, 69, Moreland Road, Niles, failure to stop after an accident and tampering with evidence;
- Christopher Gembicki, 37, Vine Street NE, Warren, vandalism;
