## **Trumbull County grand jury indicts 31**

A Trumbull County grand jury on Wednesday, July 2, 2025, returned 31 indictments.

The grand jurors also toured the Trumbull County jail examining its condition and inquiring into the discipline and treatment of the prisoners. In their report, the jurors stated they noticed rain damage and a leaky ceiling in the facility and one of the bathrooms was in dirty condition with a leaky sink. The jurors rated the treatment and discipline of prisoners as satisfactory while accommodations and overall condition of the jail as fair.
