

48 cases indicted by Trumbull grand jury

WARREN – A Trumbull County grand jury on Wednesday, Oct. 18, 2023, returned 48 indictments.

During the latest session, the grand jury also visited the Trumbull County jail, examining its state and condition and inquired into the discipline and treatment of the prisoners, their habits, diet and accommodations. The grand jury foreman reported that the rules of the jail have been “faithfully kept and observed,” the jail appeared clean and orderly, and “we do not find any provisions of law... have been violated.”
